

## DEXUS STANDARD COMPETITION TERMS & CONDITIONS

#### Terms and Conditions

1. These terms and conditions are for all entrants who enter the 'GET FESTIVE PINATA CHALLENGE' Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.

#### ELIGIBILITY

3. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over.
4.
